NOTICE OF INCOMPLETE APPLICATION

Dear Steven Gray,

The New York State Department of Environmental Conservation (Department or DEC) has reviewed the Freshwater Wetland application submitted for the above referenced project. According to the application materials, received on August 8, 2024, the proposal consists of a 534-unit residential development and associated roadway and utility infrastructure located on a 212-acre parcel in the Towns of Thompson and Fallsburg. The project will require the construction of a wastewater treatment plant as well as a water supply system including a disinfection system and water storage. A permit was issued on May 16, 2023, DEC ID 3-4899-00009/00003 & /00004, for the installation of two test wells within NYS Freshwater Wetland MO-5, Class 2, to investigate if the site had adequate water to supply the development. The application received by the Department on August 8, 2024, requests the permanent use the existing test wells at a pumping rate of up to 135 gallons per minute, the installation of a pipeline connection to the proposed development, and the installation of culverts for road and utility crossings.

Based on our review of the submitted materials, Department staff have determined that the application is incomplete. Please submit the following items for the Department to continue its review:

JOINT APPLICATION FORM

Per Uniform Procedures regulations at 6 NYCRR 621.3(a)(4), if a project requires more than one DEC permit, the applicant must simultaneously submit all the necessary applications, or demonstrate to DEC's satisfaction that there is good cause not to do so. Please submit updated materials including Joint Application Form with all permits required, and supplemental information as described below.

ARTICLE 24 FRESHWATER WETLANDS

According to the SEQRA Environmental Assessment Table 1, the total amount of proposed disturbance to NYS Freshwater Wetland MO-5, Class 2, appears to be 12,736 square feet (0.29 acres) and the total amount of disturbance to the 100-foot adjacent area appears to be 4,185 square feet (0.10 acres).

Pages 16-22 of the Joint Application Form with Attachments A-J outline the work within the wetlands, adjacent areas, and streams, however more details are needed. Please provide trenching details, culvert removal details, and installation details. The application materials mention dam repairs. Please provide more details including a narrative about the work proposed, location map of the dam, and plans, if necessary.

The permanent impacts to the wetlands are approximately 0.29 areas. This work will require wetland mitigation at a ratio of 2:1 or 0.58 acres of mitigation. Please provide details of the proposed mitigation work in the resubmission. In addition, please be aware that an issued permit would contain a condition requiring five years of monitoring and reporting to ensure long term viability.

A condition of the Freshwater Wetland permit and Water Quality Certification (DEC ID 3-4899-00009/00003 & /00004) for drilling the test wells detailed the need for reporting the results of the pump tests. Please see Natural Resource Condition #7 of the attached permit. The application materials contained reports for TW-6 but did not contain reports for TW-5. A determination cannot be made until both test well reports have been received.

Please note, New York's Freshwater Wetlands Act was amended in 2022. DEC is working to amend DEC's freshwater wetlands regulations and update procedural steps to implement these changes. As a result, the Department may reevaluate our jurisdiction for the proposed project at a later time. If additional wetlands become jurisdictional under Article 24 in 2025, please know that the Department's regulations generally require avoidance and minimization of impacts to regulated wetlands and their 100-foot adjacent areas. In situations where impacts are unavoidable and have been minimized, mitigation may be required to compensate for remaining losses of wetland benefits.

ARTICLE 15 PROTECTION OF WATER

A Protection of Waters Stream Disturbance permit is required to physically disturb the bed or banks (up to 50 feet from stream) of the stream, Tributaries of Mongaup River or East Mongaup River, Water Index Number D-10-29, Class B. A stream disturbance

permit will be needed for the construction of the new outfall and associated headwall, stream crossing for the installation of sanitary sewer and drinking water utility lines, repair of the existing Pond Dam, and the culvert crossing for the roadway as described in the application materials. The stream disturbance application information should be included on an updated Joint Application Form with the necessary supplemental information included in the resubmission. Please include the amount of linear stream disturbance for each location and note that on the plans.

STATE POLLUTANT DISCHARGE ELIMINATION SYSTEM (SPDES)

The proposal would involve discharge of the community's wastewater from an on-site wastewater treatment facility to the Class B stream on site. Construction and operation of a disposal system discharging wastewaters into surface waters of the State are regulated under Article 17 of the Environmental Conservation Law, and a SPDES permit would be required for the proposed discharge associated with this project. If a sewage disposal system is intended to serve more than one separately owned property and the legally responsible party will not be a municipality or governmental agency, the applicant involved must first form a sewage disposal corporation under the provisions of Article 10 of the New York State Transportation Corporation Law [750-1.6(f)]. This law specifies that any such corporation must be approved by both the local governing body (town, city, or village board, etc.) and the department of health (state, county, or city) having jurisdiction in that area. The corporation must be registered with the Department of State, and a performance bond must be posted with the local governing body.

In the resubmission, please submit the SPDES application with the appropriate applicant and any supplemental information required.

Please also see the note at the end of this notice regarding stormwater discharges.

WATER WITHDRAWAL

As you know, the project is in the Delaware River Basin and therefore approvals to withdraw water would be required from the Delaware River Basin Commission (DRBC). If such approvals from DRBC are obtained, the proposal would be exempt from needing to obtain a Part 601 Water Withdrawal permit from DEC per 6 NYCRR Part 601.9(b). However, if approvals from DRBC to withdraw water are not required, a Part 601 Water Withdrawal permit would be required from DEC for this project and should be submitted concurrently.

Please address this in the resubmission and provide the Department with any correspondence from the DRBC.

WATER QUALITY CERTIFICATION (WQC)

The Joint Application Form indicates that the applicant will be seeking coverage from the US Army Corps of Engineers under Nationwide Permit (NWP) 29. It is unclear if this project will qualify for the Blanket Water Quality Certification. Please provide the total amount of disturbance (in square feet) to federal wetlands and the amount of disturbance (in linear feet) to Waters of the US.

If the application does not qualify for the Blanket Water Quality Certification, the Water Quality Certification Joint Application Supplement WQC-1 Form will be required. This form can be found at https://dec.ny.gov/regulatory/permits-licenses/waterways-coastlines-wetlands/protection-of-waters-program.

The permit application mentioned mitigation for any USACE wetland disturbance over 0.10 acres but did not provide adequate information or plans for the mitigation proposed. Please provide more details about the mitigation. Please note, removing 233 linear feet of existing culverts likely requires a Stream Disturbance permit and should be included in the resubmission.

Please provide the Department with any correspondence from the US Army Corps of Engineers.

ENVIRONMENTAL JUSTICE





- is or may become a place of rodent infestation,
- is unfit for the purposes for which it may lawfully be used.

Description:

The dwelling has raw sewage running on the ground and a large number of electrical violations. Additionally, a propane tank is being used to within the dwelling unit.

This local law was enacted because of the continuing existence of abandoned and unsafe buildings. You are the owner or person interested in such building, and are hereby given notice to correct all such conditions or violations. If it is your intention to make repairs, a building permit must be obtained prior to the start of any work.

Please reply to this department within ten (10) days of receipt of this notice, thereby assuring this office of your intent to comply. Upon your failure to respond to this notice, a formal proceeding will be undertaken.
